ON PRICE QUOTATION

This text of the notice is approved by decision of the Price Quotation Commission"2" of "21" "06" 2022 and is published pursuant to Article 27 of the Law of the Republic of Armenia "On procurement"

The contracting authority Yerevan municipality, located at the following address: 1 Argishti Str, Yerevan, RA, gives notice for an price quotation which shall be carried out in one stage, through Armeps (website [www.armeps.am](http://www.armeps.am)) system of electronic procurement.

The bidder selected based on the results of the price quotation will be proposed, in a prescribed manner, to conclude a contract for **Renovation and yard improvement works** (hereinafter referred to as "the contract").

Pursuant to Article 7 of the Law of the Republic of Armenia "On procurement", any person, irrespective of the fact of being a foreign natural person, an organisation or a stateless person, shall have equal right to participate in this tender.

The qualification criteria for the persons ineligible to participate in the tender, as well as for bidders, and the documents to be submitted for evaluation of those criteria shall be established by the invitation for this procedure.

The selected bidder shall be determined from among the bidders having submitted bids evaluated as satisfying the requirements of the invitation, by the principle of giving preference to the bidder having submitted the lowest price proposal.

For receiving the hard copy of the invitation to tender, it is necessary to apply to the contracting authority by 10:00 am 04.07.2022. Moreover, an application in writing must be submitted to the contracting authority for receiving the hard copy of the invitation. The contracting authority shall ensure the of charge provision of the hard copy of the invitation (or in case of submitting, attached to the application, the copy of the document issued by the bank, attesting to the payment of AMD 1850 which may not exceed the amount of costs incurred for photocopying and delivering the invitation) on the first working day following the receipt of such request. (The payment must be made to the bank account 247010087184 of "Departmental Buildings Operation and Maintenance" CSC in "Ardshinbank". ).

In case of a request to provide the invitation electronically, the contracting authority shall ensure the free of charge provision of the invitation electronically within the working day following the date of receipt of the application.

Failure to receive the invitation shall not limit the bidder's right to participate in this procedure.

The bids for the tender must be submitted electronically, through Armeps ([www.armeps.am](http://www.armeps.am)) system of electronic procurement, **by 10:00 am 04.07.2022** The bids may, in addition to Armenian, also be submitted in English or Russian.

The bid opening will take place electronically, through Armeps system of electronic procurement, **at 10:00 am 04.07.2022**.

The appeals concerning this procedure must be filed to the Procurement Appeals Board, to the following address: Melik-Adamyan St. 1., Yerevan. The appealing shall be carried out as prescribed by this invitation to tender. For filing the appeal, a fee shall be required in the amount of AMD 30 000 (thirty thousand), which must be transferred to the treasury account 900008000482 opened in the name of the Ministry of Finance of the Republic of Armenia.
